Ordered further, That with respect to the motion to invoke cloture on the nomination of Rita F. Lin, of California, to be United States District Judge for the Northern District of California, the mandatory quorum call required under Rule XXII be waived.

Ordered further, That following the cloture vote on the Lin nomination, the Senate recess until 2:15 p.m. to allow for the weekly caucus meetings.

Ordered further, That if cloture is invoked on the Lin nomination, all time be considered expired at 2:15 p.m.

Ordered further, That upon disposition of the Lin nomination, the Senate proceed to legislative session and the consideration of H.R. 4366.

Ordered further, That if any nominations are confirmed the motions to reconsider be considered made and laid upon the table and the President be immediately notified of the Senate's actions (*Sep. 14, 18, 2023.*)
