Ordered, That upon the conclusion of morning business on Thursday, February 1, 2024, the Senate proceed to executive session to resume consideration of the nomination of Lisa W. Wang, of the District of Columbia, to be a Judge of the United States Court of International Trade.

Ordered further, That at 11:30 a.m., notwithstanding the provisions of Rule XXII, the cloture motions with respect to the Wang nomination and the nomination of Joseph Albert Laroski, Jr., of Maryland, to be a Judge of the United States Court of International Trade ripen.

Ordered further, That with respect to the motions to invoke cloture on the Wang and Laroski nominations, the mandatory quorum calls required under Rule XXII be waived.

Ordered further, That following the cloture vote on the Wang nomination, the Senate immediately vote on cloture on the Laroski nomination.

Ordered further, That if cloture is invoked on the Wang nomination, all time be considered expired at 1:45 p.m.

Ordered further, That if cloture is invoked on the Laroski nomination, all time be considered expired and the confirmation vote be at a time to be determined by the Majority Leader in consultation with the Republican Leader.

Ordered further, That if any nominations are confirmed during Thursday's session, the motions to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions. *(Jan. 30, 31, 2024.)*
